THE PROTECTION OF PERSONAL INFORMATION ACT

INFORMATION SECURITY PRIVACY NOTICE

This Notice explains how the company obtain, use and disclose your personal information, in accordance with the requirements of the Protection of Personal Information Act ("POPIA").

At Letaba Wireless Networks, we are committed to protecting your privacy and to ensure that your personal information is collected, protected and used properly, lawfully and transparently.

The information we collect

We collect and process your personal information mainly to contact you for the purposes of business transactions i.e., providing our services to your needs and expectations, and procuring of goods and services that meet the needs and expectations, and delivering services accordingly. For this purpose, we will collect contact details including your name and organisation.

We collect information directly from you where you provide us with your personal details. Where possible, we will inform you what information you are required to provide to us and what information is optional.

Website usage information may be collected using "cookies" which allows us to collect standard internet visitor usage information.

How we use your information

We will use your personal information only for the purposes for which it was collected and agreed with you. In addition, where necessary your information may be retained for legal or research purposes.

For example:

- To gather contact information;
- To confirm and verify your identity or to verify that you are an authorised user for security purposes;
- For the detection and prevention of fraud, crime, money laundering or other malpractice;
- To conduct market or customer satisfaction research or for statistical analysis;

Your Rights: Access to information

Definition of personal information

According to the Act “**personal information**” means information relating to an identifiable, living, natural person, and where it is applicable, an identifiable, existing juristic person. Further to the POPI Act, Letaba Wireless Networks. also includes the following items as personal information:

- All addresses including residential, postal and email addresses.
- Change of name – for which we require copies of the marriage certificate or official change of name document issued by the state department.
